### SET-UP

• <u>Set-Up</u> begins Saturday, September 28 from (4:00pm-7:00pm) then again at 8:00am Sunday September 29<sup>th</sup>. There will be security on duty Saturday night.

Make sure you are completely set-up by 11:00 AM as the community begins arriving early.

- You are responsible for providing your entire booth needs, i.e. extension cords, tables, canopies, chairs, etc.
- Craft booths must remain open for business the entire length of the festival.
- Traffic will flow one way. From the Odd Fellow "T" facing the registration tent, turn right and follow the loop. Do not turn around; continue to follow the entire loop.
- <u>Break down</u> is only permitted at most 15 minutes before the event is over. Those who break down before the event is over will <u>not</u> be permitted to drive through the event to pick up their items due to the safety of others. Also breaking down early may prevent you from being invited the following year. Thank you for understanding.

### ELECTRICITY

- Electricity is limited—we must know in advance your electrical needs if any. Please complete the application accurately.
- Vendors are responsible for providing extension cords. Bring the heavy-duty outdoor type (#12 wire).
- Only <u>one</u> extension cord per appliance or machine is permitted.
- All booths are subject to safety inspection.

### CRAFT/VENDOR CIRCLE

- Because of pedestrians, there will be <u>absolutely no vehicles permitted in the Craft/Vendor Circle during the festival</u> <u>hours.</u> Please park your vehicle in the designated parking area.
- Keep all tables, boxes, etc within your booth space during the festival.

### **OTHER**

- Do not give away food or drink.
- Public address systems or music is not permitted without prior approval.
- Because of the car cruise, no toys that contain or shoot marshmallows are permitted.
